- i) Suggested to have ad-hoc budget for smaller clubs who may ask two weeks before an event wider WIS committee to agree on this and discuss.
- ii) Create a focused WIS list for meetings and correct best contacts for clubs more interaction from clubs is required.
- iii) Use social media to communicate deadlines on funding applications.
- iv) Needs to be efficient and be inclusive
- v) Funding applications received so far two from Cork, one from Muckno
- vi) Need to remind the clubs of dates and application for funding.
- b) Sport week
 - i) Sport week run by sport Ireland online sessions available for women to dial into coincides with international women's week, do giveaways via Irishwwf and budget for that vouchers to cover lessons.
- c) Her Outdoors
 - i) Sport Ireland expect clubs to run events separate application that needs to be made to sport Ireland for this with funding being divided accordingly.

2) Strategy @EG

- a) Eileen Galvin ran through the draft Strategy and explained the structure of the document.
 - i) Currently in phase 1 focusing on 4 pillars set out by Sport Ireland, active participation is one of Sport Irelands main goals, what they want us to do is invest in programs that lead to sustained participation. Reduce the number of females dropping out. Difficult question do clubs want new skiers at beginner level are we encouraging at this level
 ii) Current for each address the sustained participation.
 - ii) Grants for school groups create interest locally once year
 - iii) Focus on the questions we want answered now regarding difficult questions leave them out in the first round or keep them within the WIS committee focus on the information we need for sport Ireland for now.
 - iv) Step 1 of phase 1 currently Analysing the situation before the organisation itself will be analysed and then the public.
 - v) In step 1 of phase one trying to obtain required information to analyse male / female. Agreed to use percentages as opposed to numbers. Eileen has sent out an email requesting information required and hopes to get sufficient feedback on this
 - vi) Step 2 of phase 1 candid look at the organisation internal environment before external environment
 - vii) Phase 2 Strategy setting goals and objectives.
 - viii) Phase 3 Is tactics eg trailing communication plans and evaluating
 - ix) Phase 4 evaluating what has happened
- b) Communication / participation:
 - i) Would like an email to be sent out at the start of January going forward alerting people of license required.
 - ii) Dedicated notice board with WIS information and clubs around Ireland. Create a QR code? you do have to pay. Website link included here on <u>Cost</u>
 - iii) Need to focus on younger people under 18 for officiating too
 - iv) Encourage females to use their existing qualifications
 - v) An outdoor weekend recreation level awards participation awards bring people in at a level where they are most comfortable
 - vi) Need to help people to increase their knowledge which will be done through participation

c) Leadership:

- i) Provide a pathway for people to go into leadership in the sport might be unknown to people currently
- d) Other related items:
 - i) Grant cut off March 2024 Phase 2 strategy potentially ready by March 2024. As this is unknown right now, agreed to focus on having a clear concise document ready to show what we have done and where we are going.
 - ii) Have internal KPIs to monitor ourselves dashboard for each pillar or KPI, in particular for maintaining participation Div 1 / Div 2 / Div 3. Ie moving females up from div 3 to div 2 in slalom league
- e) Note to update to Menstruation Policy minutes from Nov-23 meeting retained here for discussion in Feb-24 meeting, MA asked that we include a plan to support female skiers on managing periods. I found good information on Swim England's website. https://www.swimming.org/sport/information-female-aquatic-athletes-managing-period/#:~:text=The%20menstrual%20cycle%20is%20normal%20in%20girls%20and,that%20a%20girl%E2%80%99s%20body%20body%20bis%20preparing%20for%20reproduction. We also need a communications plan, especially for younger girls. We suggested that the plan should include female only sessions as well sessions for officials, in particular coaches.
 - i) Points for discussion on Menstruation Policy mentioned in point (c) above:
 - (1) Can we nominate a menstruation officer?
 - (2) Training / Workshops start with the females then broaden to males, provide information on coaching of females know when to push and not push know the signs
 - (3) Nutrition & Health Supplements are important to managing your period, in particular Omega fatty acids to help with PMS need to tie in with WADA prohibited list what we can and can't take can we do a workshop on this alone?
 - (4) Information posters in female changing rooms would tie in with marketing
 - (5) Toilets sanitary changing facilities are they accessible at all sites for females?
 - (6) What are the sanitary options? What are other sports doing? Swimming / Gymnastics etc do we have contacts to ask?
 - (7) Free sanitary products at clubs? Can WIS fund this?
 - (8) Should we broaden to a menstruation / menopause policy or separate this out?

ii)

- a) The list of qualified officials can be found here: https://www.irishwwf.ie/iwwf/documents/qualified-officials-2022.
- b) Judging Training
 - i) Highlighted by EG new technical committee now in place
 - First step will be to contact the technical committee (Barry Galvin for now until wider committee is known) and ask about the pathway we need to take to get more judges trained and how it would work:
 - (1) Ask them for costing new equipment needed? Etc
 - (2) What parts of the rule book do they need to focus on (Prerequisite to read the rule book to attend the introductory course online)
 - (3) Outline to technical committee focus will be on slalom Primarily slalom in Ireland tie ins in the book ie homologation.
 - (4) Hard to include all disciplines for now as wakeboarding for example is a different judging course focus on waterskiing for now – justify why we focus on waterskiing for now. (Slalom), justify why slalom on the email. WIS are also interested in training more officials for trick, jump, wakeboarding etc how can we do it for next year?
 - (5) Ask for the up-to-date rule book technical committee to ask upload Connie and add to IrishWWF website.
 - iii) Second step is a reach out via whats app and WIS email to obtain an EOI numbers of interested candidates. Ask the main committee to contact the clubs and we do WIS etc
 - iv) Third step go back to technical committee with EOI numbers. Include judges' and club contacts to ensure they are aware and obtain their cooperation for practical training.
 - v) Fourth step is to send out an email to those who expressed an interest and explain what's expected of them and what they need to read.
 - vi) Noted to be inclusive for all funded spaces are reserved for women but if men are keen they can join and if funded slots are left they can take one and if no funded space available pay a nominal fee.
 - vii) Potential outline of training pathway:
 - (1) Attendees to read rule book
 - (2) Initial one hour online
 - (3) Shadow at tournaments
 - (4) Qualification is mostly on the practical would need to do a whole summer shadowing. Chief judges or judge in charge would decide at the end of the season if people are ready to qualify. Might be written but that's up to the technical committee. Requalifying might be needed for existing judges.
- 2) Calendar @IH
 - a) The WIS calendar will only be drawn up once the dates for the International and National events have been announced
 - b) A good time of the year for WIS events is May/June, so that new skiers can start at the beginning of the season
 - c) We can have a national woman's competition, with an all-female crew, i.e. officials and skiers
- 3) IT @CK
 - a) EG and MA would like to give input to the content of the IrWWF website. EvB established that CK is collating the information for Sarah who is the web developer
 - b) Content management needs to be resolved, @EvB to contact CK in this regard
 - c) Access for Portfolio links to relevant documentation needs to be resolved, @EvB to contact CK in this regard
 - d) Rules provided under 3 (b) (ii) points (4) & (5) need to be available on IrWWF website currently there is a safety document under the rules tab of but no actual rule book for people to reference: <u>https://www.irishwwf.ie/iwwf/documents/rules</u>

 - a) We are still looking for a lead for the marketing portfolio
- 5) Talent @TBD
 - a) We are still looking for a lead for the talent portfolio. This portfolio would have a large overlap with the education portfolio and we need to decide is we need this portfolio
